<ul style="list-style-type: none"> • I agree to enroll in Tuition Express and understand that my child’s monthly tuition and early and late care fees will be paid automatically via credit card or bank account.
<ul style="list-style-type: none"> • I understand that failure to make timely payments may result in the termination of my child’s enrollment in StoryHeights Montessori Summer Program.
<ul style="list-style-type: none"> • I understand that I am responsible for picking up my child by the contracted time and that I will incur a late fee of \$1.00 per minute for picking up my child after the contracted time. Late fees are charged after 12:00 pm, 4:00 pm and 5:30 pm.
<ul style="list-style-type: none"> • I understand that students attending StoryHeights Montessori only for the summer must pay for all sessions upon registration. Failure to submit the signed Enrollment Contract and/or payment by the required deadline may result in the forfeiture of my child’s spot. • <u>I understand that any/all payments for the Summer Program is/are non-refundable under any circumstance, including if I withdraw prior to my child’s start date, regardless of when such notice is given.</u>
<ul style="list-style-type: none"> • Camp payments are non-refundable should my child not complete the summer program due to absence, withdrawal or dismissal.
<ul style="list-style-type: none"> • I understand that if I choose to increase my child’s care at any time, and SHM is able to accommodate this need, I am required to pay the difference to reflect the new amount prior to his/her first day of care under a new contracted tuition amount. I understand that I will be required to sign a new enrollment contract at the time that I choose to increase care. • In the event that, at any time, I choose to decrease my child’s care needs, I will receive no refund for payments already made.
